Message from the Chair

of the Board of Directors and

the Executive Director

In the past three years, Marie-Vincent has experienced phenomenal changes. It all began with our heartfelt appeal for help to deal with our services' waiting time. From the moment it was determined that over 500 children and teens were waiting up to 2 years to access the services they needed, we made every possible effort to improve the situation.

Part of the answer lied in the launch of a major fundraising campaign - **"Overcoming the unimaginable, rediscovering hope."** The goal of this campaign, masterfully carried out by its president Charles Emond, President and Chief Executive Officer of the Caisse de dépôt et placement du Québec, was to raise 9.5 million dollars over three years.

Clearly, our call for help was heard far and wide; we are proud to report that we raised 14.7 million dollars which will help us support young victims until 2028!

Not only is this unexpected success an encouraging sign for Marie-Vincent but it has already had a tangible and sustainable impact on the lives of young people. The past year has been particularly exceptional, marked by many challenges, historic results and the culmination of projects that will shape Marie-Vincent's future.

Since 2021, our team has been hard at work reviewing our Sexual violence intervention program. We created over 40 new positions within our organization, thirty of which are dedicated to direct services for the children and our partners. This led to a 16-month reduction in waiting time for our clientele, on average. And our work continues!

We have been keeping busy with the opening of our 2nd Marie-Vincent centre based in the Montérégie, developing new partnerships and planning for and moving into our new Montréal location. As for prevention and training, Marie-Vincent has kept up its excellent work. By adapting our Sexual violence prevention program for younger children to better serve the needs of children aged 6 to 12 as well as children with special needs aged 4 to 12, we can look to the future with hope. We continue to work with adolescents, thanks in part to the implementation of a sexual exploitation and trafficking prevention project with at-risk youth.

Providing structure, support and a solid foundation for our growing organization

Marie-Vincent remains driven by its hope of building a protective community for young people. We will continue to rise to the challenge, designing an organizational structure that supports our exponential growth effectively. The goal is to integrate innovations, to continue our work with vulnerable children and teens while being outspoken advocates for prevention.

We would like to express our deep appreciation to all our employees. Their passion and hard work continue to be the foundation upon which our achievements are built.

Our commitment to the quality and accessibility of our services in our Montréal and Montérégie centres

Marie-Vincent benefits from the expertise of an exceptional multidisciplinary team that distinguishes itself by its empathy and dedication to the young people who need our help. Our efforts have been focused on consolidating our Sexual violence intervention program so as to strengthen our commitment to our mission and to ensure the support we provide meets the needs of our young clientele. The impacts are tangible and we will continue our work in the coming year.

Our resolve to provide young victims of sexual violence with high quality services and care is one of the key pillars of our mission. With our integrated approach, all these services are provided under the same roof. In parallel, our close collaboration with the Marie-Vincent Interuniversity Research Chair in Child Sexual Abuse provides us with the means to assess our services and their impact on our clientele, reaffirming our resolve to develop a high degree of expertise.

Our clinical services were still particularly busy this past year, a trend that sadly reflects the steady call from young people for support services. We tackled several challenges and reached important milestones this year so as to help our clientele and provide services that are tailored to their needs.

 We launched an extensive review of our waiting list, contacting each person directly to make a better assessment of their needs and explaining the services we offer so as to make sure that their decision to remain on our waiting list is made voluntarily. This monumental undertaking has led to a substantial reduction of our waiting list, dropping from 503 to 359 children, i.e. 144 fewer children, despite receiving 362 new service requests over the same period. children and teens received Marie-Vincent services, 185 taking advantage of our therapeutic services and 166 benefiting from a psychosocial intervention.

The average wait time for the clientele we met in 2022-2023 for psychosocial or psychotherapeutic services fell to **16 months** from last year's 18-month average.

104

individuals took advantage of our immediate intervention services following a referral or a police investigative interview carried out in our centres. Each person took part in an average of 4 meetings through this service.

Among them:

- 90 were biological or foster parents;
- 14 were adolescents.

28

parents were able to benefit from our parental support program while their children were cared for by our psychosocial or psychotherapeutic services.

535

advisory services provided to our partners and professionals, over **212 hours** of work in total.

71 police investigative interviews.

A year ago, we marked another important milestone when the new Montérégie Marie-Vincent Child & Youth Advocacy Centre (CAEJ) opened its doors. This inauguration embodies our commitment to provide better access to our services.

30% of the children previously on our waiting list were from the region and did not have access to any local services.

One year on, we can safely say that the Marie-Vincent CAEJ in the Montérégie plays a key role in identifying each young persons' specific needs and implementing the appropriate intervention and support measures. Additionally, important partnerships were built and strengthened, particularly with the Mercier and Châteauguay police departments as well as the Sûreté du Québec. Thanks to these agreements, police investigative interviews of young victims can take place in our centre. This environment is obviously more welcoming than a police station, paving the way to a fruitful collaboration, while the young victim remains at the centre of our collective efforts.

The commitment of our Prevention and Training services is reflected in our determination to build a protective community for young people and our aspiration is to create a future free of sexual violence. By bringing actors of change together and training them not only to recognize signs of sexual violence but to address them effectively, we are determined to make this vision a reality.

By working together, we can prevent sexual violence and create a future where every child can thrive, free from harm.

Our prevention and training services play an essential role in the fight against sexual violence. Through education and awareness initiatives, we empower communities to protect young people, notably by training early childhood educators, health and social services professionals as well as police officers. We also develop and implement prevention programs tailored to the needs of children of all ages, from the littlest toddlers to adolescents as well as their loved ones, to help prevent sexual violence before it happens.

Prevention

The evolution of the Lantern Program for ages 6 to 12 and children with special needs aged 4 to 12

In the past few years, there has been great interest from the community and education sector for Lantern, our sexual prevention program that builds on sexuality education and the promotion of egalitarian relationships with toddlers and young children aged 0 to 5. Many of these organizations encouraged our team to develop a follow-up for children aged 6 to 12 and to adapt the program for children with special needs.

Funding from the Public Health Agency of Canada provided the means to answer their call to help prevent sexual violence even better with children aged 6 to 12. A contribution from the Lucie and André Chagnon Foundation also paved the way to the Lantern Program's adaptation for 4- to 12-year-olds with special needs. Thanks in part to stimulating meetings with partner organizations and by spearheading discussion groups, we've made tremendous strides in both projects in 2022-2023, setting strong foundations toward developing tools and training programs based on best practices that meet the specific needs of these new target audiences.

Training

Expanding socio-judicial component

This past year was marked by the significant development of the training service's socio-judicial component, particularly due to funding from Québec's Ministry of Justice and a partnership with the École nationale de police du Québec (ÉNPQ). The training offer is more diverse and more accessible thanks to:

- The creation of the "Accompagner l'enfant victime de violence sexuelle et ses proches à travers la trajectoire sociojudiciaire" e-training.
- The implementation of a development plan for the revised NICHD-based non-suggestive investigative interview training.
- The participation of the Marie-Vincent team at several conferences and events including the launch of the Specialized Court schedule and the Ordre professionnel des criminologues du Québec Conference.

This steady expansion of our service offer allows us to better meet the training needs of professionals in the socio-judicial sector who support young victims of sexual violence.

Overview of training activities

More than 300 training sessions were held between April 2022 and March 2023, an increase of nearly 50% from the previous year.

So long Papineau, hello Angus!

Some twelve months ago, we were faced with an incontrovertible truth: our Montreal location on Papineau avenue was no longer suited to our needs and future objectives. This realization led to our moving to a new and welcoming 2-floor, 20,000 square-feet location with a contemporary design at the very heart of the vibrant Technology Park Angus in the Rosemont-La Petite-Patrie borough. Now that some months have passed, we are settling into our new location, carefully thought out to suit our clientele, our partners and our team.

A new sustainable development charter

In 2022, the Caisse de dépôt et placement du Québec (CDPQ) chose Marie-Vincent, among other organizations, to benefit from the expert guidance of the Réseau des femmes en environnement (RQFE), free of charge. The RQFE professionals evaluated and guided us, providing tools and advice over a one-year period. This process led to the creation of our sustainable development charter as well as a flexible action plan informed by three guidelines:

- Adopt more environmentally responsible behaviours when working remotely and at the office;
- 2. Support employee well-being;
- **3.** Raise the awareness of stakeholders through our activities.

An employee committee was created in the fall of 2022 to assess previous actions and set out our priorities for the years ahead. This is a new addition to other entirely voluntary employee committees that perfectly capture our team's commitment and mobilization in all areas of our organization: Job evaluation committee, Social committee, Racial equality, diversity and inclusion committee, and our most recent, the Occupational health and safety committee, formed in winter of 2022.

A 17-year collaboration, developing and improving specialized services:

Thanks to the Marie-Vincent Interuniversity Research Chair in Child Sexual Abuse, our organization develops leading-edge scientific knowledge on child sexual abuse. The Chair's work is guided by four objectives:

- Increase knowledge to allow Marie-Vincent's stakeholders and partners to develop specialized services and improve service quality for victims (0-17 years) and their loved ones, as well as for children aged 12 and under with problematic sexual behaviours.
- Disseminate research results on the nature and consequences of sexual abuse, on the assessment of the specialized prevention and intervention services provided by Marie-Vincent and its partners along with their impact on their young clientele in order to further the development of cutting-edge practices and knowledge.
- Train a new generation of highly-skilled professionals who will benefit from an exceptional research environment due to the proximity of Marie-Vincent and its services.
- Enable Marie-Vincent to exercise leadership in the development of specialized services and in cutting-edge training.

The Chair's research program revolves around three axes:

- **1.** Identify developmental profiles and pathways.
- **2.** Evaluate the services provided and the trajectories of psycho-socio-judicial services.
- 3. Evaluate prevention initiatives.

As in previous years, we want to acknowledge the contribution of their team, namely our two co-chairholders, Mireille Cyr at Université de Montréal and Martine Hébert at Université du Québec à Montréal, associate researcher Isabelle V. Daignault, an Associate Professor at Université de Montréal's School of Criminology, data banks and analyses coordinator Manon Robichaud, research technician Josée Thériault, as well as all the students and associate researchers.

A few highlights

One of the Chair's achievements in the past year was the publication of a clientele assessment carried out in September 2022 with 83 parents, 72 children and 37 adolescents:

60%

of all parents say that their child communicates much more with them since undergoing therapy at Marie-Vincent.

90%

of those are highly satisfied with the services received at Marie-Vincent.
