

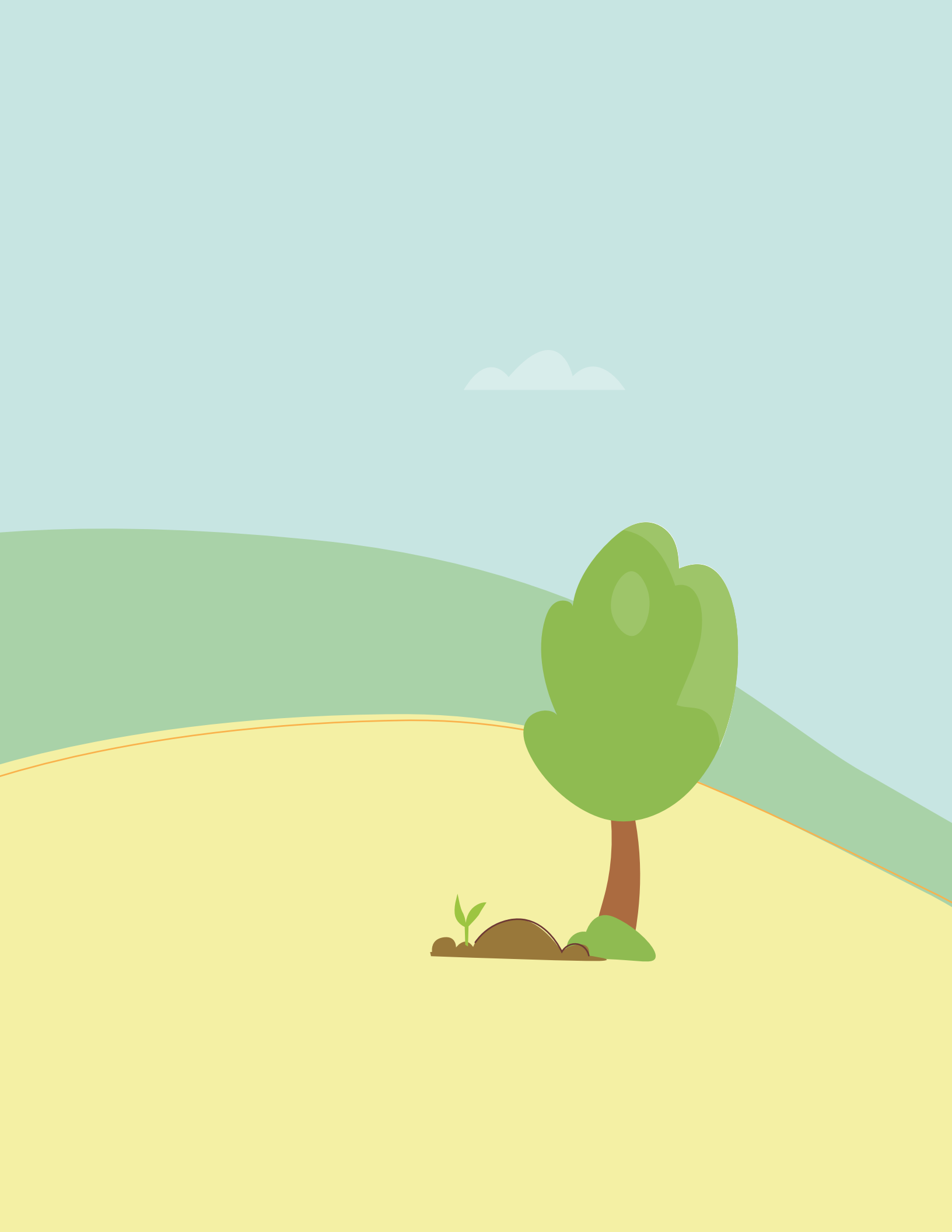

# The Year in Summary

## Family Services

**359** children and youths benefitted from Marie-Vincent services

**247**

## Prevention and Training

## Private and Public Funding

Private donations accounted for 47% of our total funding. Grants and government contracts accounted for 43%.

This year is particularly meaningful: 2025 marks the 50th anniversary of the Marie-Vincent Foundation. 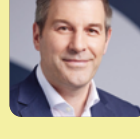

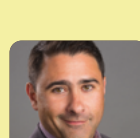

# Our Team

Our team is composed of **87** persons working at the Foundation and in our two child and youth advocacy centres (CYAC). Marie-Vincent recruited **21** new people in 2024-2025.

## A Look Back

### at HR Initiatives

This year, the Human Resources department continued to support the various departments in their restructuring efforts (creation of new positions, review of roles and responsibilities, etc.). The arrival of a human resources manager and a technician to support the existing manager has enabled us review everyone's roles to ensure the delivery of HR files and projects in line with the organization's growth.

Considering our mission, we paid close attention to overall wellbeing. With that in mind, and thanks in part to funding from the ministère de la Justice du Québec, support groups were made available to Marie-Vincent staff in 2024-2025 – an initiative that is ongoing in 2025-2026. It also enabled us to provide specific support to clinical practitioners by creating safe spaces for discussions with an external psychologist, both for groups and individuals.

Frequent consultations were held with staff to more clearly discern their needs and thus foster retention. This exercise covered several areas, including internal HR policies, recognition, and engagement. The last survey, conducted prior to March 31, 2025, revealed an employee satisfaction rate of 80%!

## Mission Support:

### A Devoted Team

**To support Marie-Vincent's mission and specialized services, a dedicated team, working across multiple departments, supports activities through various strategic and operational components.**

It leads projects related to finance, administration, information technology, and communications. This behind-the-scenes work, discreet yet essential, ensures the organization's continuity, agility, and visibility.

### Cybersecurity and Digital

#### Environment: A Major Initiative

Issues related to cybersecurity, compliance with Law 25, and the modernization of our digital environment required the allocation of significant resources in 2024-2025. This focus will culminate in 2025-2026 with the complete migration to the Microsoft 365 environment, the adoption of an internal privacy policy, and the launch of a new, more secure and streamlined website. Awareness and training activities on cybersecurity and privacy protection have also been implemented for our staff and will be maintained on an ongoing basis to strengthen our culture of digital vigilance.

## 5 In-House Committees

Marie-Vincent boasts five in-house mobilizing committees that were created to actively involve personnel in the key issues that define our organizational culture. The **health and safety committee** oversees prevention and the safety of all employees; the **diversity, equity, and inclusion (DEI) committee**, for its part, aims for a fairer, more representative and caring working environment. The **sustainable development committee** recommends concrete ways to reduce our environmental footprint. The **cybersecurity committee** suggests sound practices for protecting data in an increasingly digital world. Lastly, the **social committee** works to forge cohesion among colleagues and a feeling of belonging.

As a whole, these committees help create a healthy and inspiring work environment that is consistent with Marie-Vincent values.



# Clinical Services for

## Children, Youth and Families

Our clinical services, available at our Montréal and Châteauguay centres, are provided to a client base in the greater metropolitan area that includes Laval, the Laurentians, and Montérégie, thereby enabling access to specialized support for more young people and their families.

### The Marie-Vincent Model:

#### All Services Under One Roof

Marie-Vincent is a member of the network of child and youth advocacy centres (CYAC) of Canada, which numbers more than 40 other centres. The CYAC model, recognized globally, is based on a coordinated, multidisciplinary approach that prioritizes the needs of the young people concerned and their families. As such, thanks to our partners, all services are grouped under just one roof at Marie-Vincent: from psychosocial and psychotherapeutic counselling to medical examinations, police investigative interviews to guidance and support throughout the judicial process.

For victims, this integrated approach helps minimize travel time, facilitates the intake process, is more smoothly coordinated and less stressful for child victims of sexual violence and children presenting sexual behaviour problems and their families, and reduces the long-term impacts of sexual violence.

## An Unwavering Commitment to Supporting Young Victims

At Marie-Vincent, we are committed to reducing the negative impacts of the socio-judiciary process on the children and youths we support. We achieve this aim by strengthening ties with our various partners, such as law enforcement, medical teams, and the professionals at CAVAC (the Crime Victims Assistance Centre).

### Spotlight on the Centre for Child and Youth Advocacy (CYAC) of Montréal

The Service de police de la Ville de Montréal (SPVM, the local police department) **conducts most of its investigations into the cases of young victims of sexual violence at our offices**, which minimizes travel time and reduces stress for children and their immediate entourage.

Twice each month, the CHU Sainte-Justine team travels to our offices to meet with children and youths in our medical consultation room, which was specially designed for the purpose. A pediatrician and nurse clinicians are also on hand to respond to the specific needs of our client base.

Our team also takes care to refer to the Programme Témoin Enfant (PTE) all children facing time in a courtroom. This program was developed by CAVAC to prepare child and teen witnesses (ages 5 to 17) for an eventual appearance in court. The organization's staffers meet with the youngsters in our offices and are supported by a Marie-Vincent clinician who will have already established a rapport with the children and youths.

Lastly, we have made good use of a centralized pool of interpreters. Over the past year, we submitted **130 requests** for language services, which has helped us respond fairly and in keeping with clients' linguistic needs.

### Spotlight on the Centre for Child and Youth Advocacy in Montérégie

Our presence in the Montérégie region has enabled us to develop regional agreements and alliances, thereby strengthening the accessibility, reach and funding of our activities. Marie-Vincent is still **the only establishment** to provide integrated psychosocial and psychotherapeutic services to young victims of sexual violence in the region.

Our offices are now available to law enforcement partners three days per weeks to facilitate their presence and collaboration with our clinical team. We continue to be involved on various local round tables and committees to fulfill our key role of preventing sexual violence and supporting young victims.

Lastly, our proximity to the local Chambre de commerce et d'industrie Grand Roussillon encourages philanthropic networking with the local business community.



## Services

### to Parents

Over the past year, **221 parents have benefitted from immediate intervention service or specialized support** from our clinical team. That number attests to the pressing need to support young victims of sexual violence and children presenting sexual behaviour problems. With targeted funding from the ministère de la Justice du Québec, we have analyzed and validated the parameters of this parental support, provided by Marie-Vincent in cooperation with our Research Chair. This strategic service has helped us fine-tune the structure of our offer, document the benefits and lay the foundations for even more case-specific support.

## Zootherapy

### Pilot Project

In 2024, with an eye to expanding the therapeutic approaches available to children and youth, Marie-Vincent established a working committee in 2024 to study the establishment of a zootherapy pilot project. To that end, one of our team members took a training course and completed an internship in animal therapy from April to June 2024 at our Montréal offices. This experience laid the groundwork for our exploration of the therapy's known benefits, especially as regards the expression of emotions, regulation, motivation and focus on the present moment in a clinical setting. As a result, we are establishing a one-year pilot project in Spring 2025 with a canine unit certified by the Corporation des zoothérapeutes du Québec, which will engage in certain targeted treatments in Montréal. The project is an expression of our unflagging commitment to provide sensitive, customized and innovative services.

## Interuniversity Research

### Chair on Child Sexual Abuse

For nearly 20 years now, the Marie-Vincent Research Chair has contributed to the development of Québec's expertise in prevention, screening, and intervention for child victims of sexual violence and children presenting sexual behaviour problems.

The Chair's work has led to expansion of expertise, the development of specialized tools, and an assessment of services with a view to:

- ensure that our clinical team constantly improves its practices and deliver the most specific support to young victims and their immediate entourage;
- enable our prevention/training team to develop the most effective prevention and training programs.

The Chair does in fact play a key role in training the next generation of highly qualified clinicians and scientists. Its leadership drives the advancement of national and international expertise in preventing and addressing sexual violence against young victims and supporting children presenting sexual behaviour problems.

Its role is seen in multiple contributions to international conferences, numerous publications of scientific articles, and the mentorship of master's and doctoral students. In concrete terms, the Chair has also supported the Marie-Vincent team in the following projects:

- Completion of the qualitative and quantitative evaluation of the Lantern Program (ages 0-5).
- Start of the evaluation of the Compass program (ages 6 to 12)
- Support for the development of the Voies project (ages 4-12 with specific support needs).
- Evaluation of the Heads or Tails project (prevention of sexual exploitation and human trafficking of at-risk youths)
- Needs assessment for the development of a prevention program addressing violence and online sexual violence in youth sports (ages 13 to 17)
- Assessment of two pilot projects designed to bolster support to parents
- Collaboration on the zootherapy pilot project
- Literature review and best clinical practices review with regard to physical violence.





Continuing the focus on innovation and knowledge-sharing, the Chair works with Marie-Vincent to organize monthly meetings called “Sucré-Salé.” These essential gatherings between our two teams is designed to facilitate discussions on research findings and practice, fostering collaboration and strengthening our ties.

In 2024-2025, the following topics were covered:

- Providing support services to radicalized families or those from immigrant backgrounds
- Creation, development and implementation of the Compass Project: Prevention of Sexual Violence Against Children Ages 6 to 12
- Key findings from the needs assessment for the youth sports violence and cyberviolence prevention project
- Beyond generalizations: Understanding the diverse profiles of children exhibiting sexual behaviour problems
- Self-regulation in children who have experienced sexual abuse
- Training professionals in the prevention of childhood sexual abuse: A mixed-method evaluation of the Lanterne Program
- The importance of the therapeutic alliance in the treatment of anorexia nervosa in adolescent girls
- Victimization profiles of mothers of children who have experienced sexual abuse and links to their mental health and coping strategies – a latent class analysis
- Protective school and community factors contributing to the resilience of children who have experienced sexual abuse

To mark the 100th Sucré-Salé, we feted the retirement of Mireille Cyr, co-holder of the Research Chair from 2005 to 2024. A pioneer in the field, Cyr’s work has helped position Marie-Vincent at the forefront of expertise and practice in addressing sexual violence against children and youths.

# Training and

## Prevention Projects

The Marie-Vincent team tasked with prevention and training plays a key role in preventing sexual violence against children, each year **training thousands of professionals across Québec** and implementing numerous target-specific projects.

The team works on behalf of a vast swath of professionals in the sectors of education, early childhood education, health, social services, and community and socio-judicial organizations, thereby developing a protective community throughout the province. The approach is founded on a range of educational practices using the latest scientific data stemming from the close collaboration with the Marie-Vincent Interuniversity Research Chair.



## Prevention

Project for the prevention of sexual violence against adolescents and their immediate entourage supported by the Secrétariat à la jeunesse (SAJ):  
Four-year report (April 2021 to March 2025)

This project was an important milestone in our work to create safer environments for children and youths, and to equip professionals with the tools that will best respond to the complexity of adolescent cases of sexual violence.

The key results are:

- More than **9,000 youths ages 12 to 17** reached, using innovative prevention tools and training content tailored to their needs.
- **228 school caseworkers** trained in prevention of online sexual violence.
- **6 schools** that have implemented the peer-training approach (PTA)
- **546 intervention kits** for cases of sexual exploitation enhanced and distributed; and **481 practitioners** trained to use them.



## Lantern, Compass and Voies:

### Broadening the Reach of Sexual

### Violence Prevention From an Early Age

Launched in 2019, the Lantern Program was a forerunner in terms of sexual violence prevention for children ages 0 to 5. Its focus was on sex education and the promotion of healthy, egalitarian relationships. Lantern has since inspired the development of two new projects (in progress):



#### Compass Program

(ages 6-12)

With the same intention, the Compass project strives to fill the gap, mentioned by various community and school organizations, for specific programs for children between the ages of six and 12. Compass represents the trusted adult who guides children through their psychosexual development.

Compass offers community workers and day/summer camp and recreation staff a free 9-hour training course as well as asynchronous training for camp counsellors. Each organization receives a teaching kit containing fun tools suitable for children, professionals and parents.

The Compass project will enable us to **reach and train 900 people across 125 organizations**, and the entire project will be evaluated together with the Marie-Vincent Interuniversity Research Chair; a final report is expected in Spring 2026.



#### Voies project

(children 4 to 12 with  
special support needs)

Another offshoot of the Lantern program, the Voies project offers concrete means to better respond to children requiring special support in order to prevent sexual violence. This project specifically targets children aged 4 to 12 who face cognitive and/or communication challenges, such as:

- Mild intellectual deficiency
- Autism with mild support needs
- Developmental language disorder (DLD)

The Voies project offers a range of sex education content tailored to the needs and psychosexual development of children to strengthen their autonomy and promote egalitarian relationships from an early age. It provides intervention guidelines for practitioners and professionals in cases of disclosure or concerning sexual behaviours. Although these children are particularly vulnerable, few preventive initiatives are dedicated to them. Thanks to the support of the Lucie and André Chagnon Foundation, the Lantern program has been enriched with new tools and specialized training to better meet the needs of this group.

The Voies project will **reach more than 700 professionals** and will also be evaluated by the Marie-Vincent Interuniversity Research Chair over the coming year.



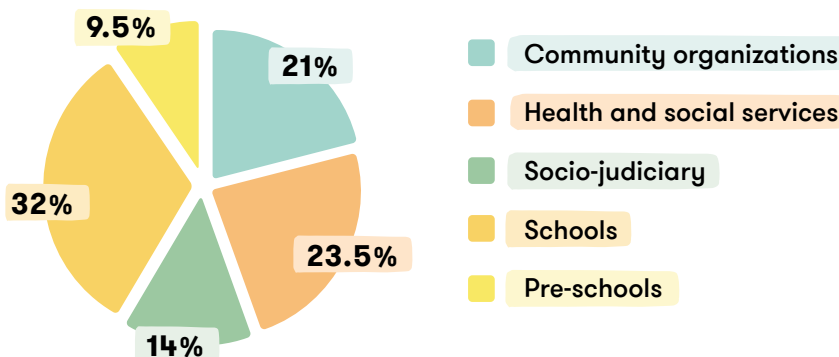
## Training

More than **300 training sessions** were made available between April 2024 and March 2025, teaching over **6,000 practitioners!**

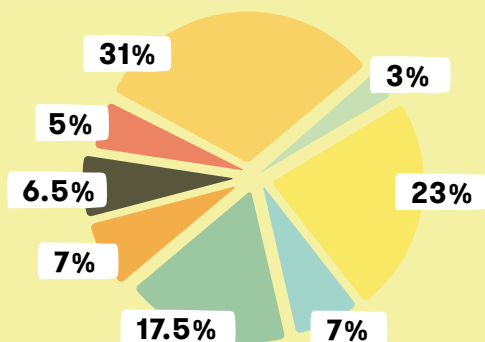
**878** individuals took the recorded training sessions, which included online training and rebroadcasted webinars.

### Guiding a child victim of sexual violence and their immediate entourage through the judicial process: Report on a project supported by the ministère de la Justice du Québec (MJQ)

This two-year project was intended to reinforce professional skills in the socio-judicial sector in order to better support child victims of sexual violence through their journey. The top results are as follows:

- **23** synchronous one-day trainings held live or online, **261** Québec professionals trained
- **265** illustrated albums (*Un pas à la fois avec Lou*) and **243** support guides distributed to participants and partners
- **1,688** views of the illustrated 2D animated album





This project marks an important step in strengthening professionals' ability to support young victims in their socio-judicial journey. The interest generated by the training demonstrates its impact on professionals. We therefore plan to continue the training for various groups.

### Training Courses for the Primary School Environment

For more than five years, Marie-Vincent has been providing training to school personnel with the support of the provincial education department. In 2024, the agreement was renewed for an additional three years to continue holding the training courses and to create a customized program for preschools (ages 4 to 6).

Our training programs are intended to develop best practices and improve confidence during interventions in cases of sexual assault disclosure or when students exhibit sexual behaviour problems. The courses are available to all school staff -- teachers, school intervention specialists, psychologists, specialized educators, psychoeducators, etc.

In 2024-2025, **77** training sessions were held for **1,585** individuals.

### On-Demand Partnerships and Training

To meet the needs of as many organizations as possible, we offer a wide variety of training programs through on-demand projects or longer-term partnerships. Accordingly, in 2024-2025, two new partnerships were established, two customized training projects were completed, and more than **20** regular or specialized training sessions were held for various groups, totaling more than **35** training programs taught.
